

NOTICE OF ELECTION

UK Parliamentary General Election for

SOUTH DERBYSHIRE

1. An Election is to be held of one Member of Parliament for the constituency of South Derbyshire.
2. Forms of nomination for the Parliamentary Election may be obtained at Civic Offices, Civic Way, Swadlincote, Derbyshire, DE11 0AH from the Acting Returning Officer who will, at the request of an elector for any electoral area prepare a nomination paper for signature.
3. Nomination papers must be delivered to the Acting Returning Officer at the Civic Offices, Civic Way, Swadlincote, Derbyshire, DE11 0AH on any day after the date of this notice between the hours of 10 am and 4 pm but no later than **4 pm on Friday, 7th June 2024**.
4. The **£500** deposit can be paid by legal tender, by means of a banker's draft from a drawer which carries on business as banker in the United Kingdom or by electronic transfer to **Barclays Bank, Sort Code: 20-63-36, Account: 60564869** (Use reference **GE DEPOSIT** followed by candidate surname).
5. If any election is contested the poll will take place on **Thursday, 4th July 2024**.
6. Applications to register to vote must reach the Electoral Registration Officer at the Civic Offices, Civic Way, Swadlincote, Derbyshire, DE11 0AH by **12 midnight on Tuesday 18th June 2024**
7. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Civic Offices, Civic Way, Swadlincote, Derbyshire, DE11 0AH by 5 pm on **Wednesday, 19th June 2024**.
8. Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer (insert address) by 5pm on **5 pm on Wednesday, 26th June 2024**.
9. New applications to vote by proxy at this election must reach the Electoral Registration Officer at Civic Offices, Civic Way, Swadlincote, Derbyshire, DE11 0AH by **5 pm on Wednesday, 26th June 2024**.
10. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Civic Offices, Civic Way, Swadlincote, Derbyshire, DE11 0AH by **5 pm on Thursday, 4th July 2024**. The physical incapacity must have occurred after **5 pm on Wednesday, 26th June 2024** and evidence must be provided. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after **5 pm on Wednesday, 26th June 2024** and provide evidence to support this.
