

## Public Notice

### Community Governance Review of the Drakelow Area

On 27 June 2024, South Derbyshire District Council considered the results of consultation, an assessment against statutory criteria and adopted the following Final Recommendations in respect of the Community Governance Review about parish arrangements in the Drakelow area. The Council agreed to conduct the Review in November 2023, further to Section 79 of the Local Government and Public Involvement in Health Act 2007, following the receipt of a petition signed by 271 local electors.

The Final Recommendations are that:

1(a)	the existing Parish Meeting for the parished area of Drakelow is abolished on 31 March 2025 and replaced with a Parish Council.
1(b)	a Parish Council for the parished area of Drakelow is constituted with effect from 1 April 2025.
2	the new Council for the parished area of Drakelow is styled as a parish council and constituted as "Drakelow Parish Council".
3	the area and boundaries of Drakelow Parish Council remain the same as those on which the current Drakelow Parish Meeting is based.
4	Drakelow Parish Council has nine Parish Councillors when it is created in 2025 and that this rises to eleven when the number of local electors reaches 905.
5	there will be no Parish Wards in Drakelow Parish Council's area.
6	in accordance with the statutory Guidance on Community Governance Reviews, Drakelow Parish Council is established with effect from 1 April 2025 and local elections are held in May 2025.

The District Council will now prepare an Order (a legal document) to bring the above recommendations into effect on the dates indicated and will notify local electors and stakeholders about the outcome of the Review and the reasons for the Council's decisions. When the Order is made, a copy will be available for public inspection together with a map showing the area and boundaries of Drakelow Parish Council when it is created.
