- kerb or border stones (for a space not exceeding 6'6" x 3')	320.00
- a vase not exceeding 18" in height	91.00

- Etwall Cemetery: supply of 7" x 5" wall plaque inclusive of inscription up to 70 letters	295.00
- replacement of memorial stone	160.00
