Review of Polling Districts and Polling Places 2024

South Derbyshire Constituency (Acting) Returning Officer's Proposals

1 Background

In accordance with the Representation of the People Act 1983, local authorities are required to divide their area into polling districts, to designate polling places for those polling districts, and to keep their electoral arrangements under review.

The Electoral Registration and Administration Act 2023 requires South Derbyshire District Council (The Council) to complete a review of parliamentary polling districts, polling places and polling stations by 31 January 2025.

The purpose of the Review is to ensure that, so far as is practicable in the circumstances;

- a) all electors in the parliamentary constituencies within the District have such reasonable facilities for voting and
- b) every polling place is accessible to electors who are disabled.

The legislation requires that the reviews are carried out based on Parliamentary Constituencies. This Review has been carried out on the parliamentary constituencies of South Derbyshire and the parts of Derbyshire Dales Constituency that are within the South Derbyshire District.

The (Acting) Returning Officer for the Derbyshire Dales Constituency has been consulted as part of this Review.

This Consultation Document has been produced as part of the Review.

2 The Review Timetable

The Review commenced in September 2024 and is scheduled to conclude on 31 January 2025, following the timetable below-

3 Review Principles

The (Acting) Returning Officer has conducted the Review on the basis of the following principles-

- To simplify the boundaries of Polling Districts.
- To allow for projected population growth.
- To ensure that Polling District boundaries conform to the new County Division boundaries whilst continuing to align with existing District Ward and Parish boundaries.
- To ensure that Polling Stations are accessible to persons with disabilities.
- To ensure elector numbers do not exceed the Electoral Commission recommended maximum of 2250 per Polling Station.
- To, where possible, avoid the use of mobile Polling Stations due to cost and general inconvenience.
- To use double and triple Polling Stations at Polling Places where possible.
- To ensure a Polling Place every Polling District unless there are no alternatives.
- To minimising community disruption in holding a Poll (e.g. avoid using schools as Polling Places where possible as schools often have to close).
- To not increase the number of Polling Stations in the District (currently 78) as it is difficult to find venues and staff the Polling Stations

4 Response to Initial Consultation (9 September 2024-21 October 2024)

The Initial Consultation was published on the Council's website and was sent to the list of consultees at Appendix 1

The (Acting) Returning Officer received several comments and responses to the Initial Consultation. These are detailed in the Table below together with the (Acting) Returning Officer's response.

The (Acting) Returning Officer also requested feedback from Presiding Officers, Poll Clerks and Poling Station Inspectors during the 2024 General election. The feedback from this consultation is incorporated into the (Acting) Returning Officers comments and proposals at section 5.



Boundary of Polling District ASD, the area shaded orange, to extend to include the area shaded Yellow, currently part of Polling District ASC.





Polling District ETD, the area shaded orange, to merge with Polling District ETC, the area shaded yellow, to create a new combined Polling District titled ETC.






Proposed that Polling District MWA, shaded orange, is to merge with Polling District MWB, the area shaded yellow, to create a combined Polling District titled MWA.







Proposed that a new Polling District is created and titled SWF, shaded yellow, from part of SWA.






6. Conclusions

The (Acting) Returning Officer is satisfied that the proposals in this document reflect the principles as detailed in Section 3 of this document and ensure that the Parliamentary Polling Districts and Polling Places comply with the following requirements-

- In England, each parish is to be a separate Polling District.
- The Council must designate a Polling Place for each Polling District unless the size or other circumstances of a Polling District are such that the situation of the Polling District are such that the situation of the Polling Stations does not materially affect the convenience of the electors of any body of them.
- The Council must seek to ensure that all electors in a constituency in its area have such reasonable facilities for voting as are practicable in the circumstances.
- The Council must seek to ensure that so far as is reasonable and practicable every Polling Place for which it is responsible is accessible to electors who are disabled.
- The Council must have regard to the accessibility to disabled persons of potential Polling stations in any place which it is considering designating as a Polling Place or the designation of which as a Polling Place it is reviewing.
- The Polling Place for a polling District must be an area in the District, unless special circumstances make it desirable to designate an area wholly or partly outside the District.

In addition, the (Acting) Returning Officer is satisfied that these proposals make adequate provision for anticipated increase in elector numbers due to proposed housing developments and for the change in County Division boundaries following the County Council Boundary Review.

The Proposals are designed to have the least possible impact on electors and result in a net decrease of two Polling Stations.
