a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

We aim to achieve the four licensing objectives through (1) staff training which will be carried out every six months. (2) Correct signage within the premises. (3) Cognisance of any impact the premises may have on the community and environment with planning to reduce any risk of harm or nuisance. (4) Health & Safety of the public whilst on our premises and in particular the protection of any children from harm. (5) Reducing the premises closing time to 11pm.

b) The prevention of crime and disorder

(1) Staff Training will be carried out every six months and recorded for inspection by the Police or an authorised officer of the local authority in the Licensing Act 2003 and in particular Challenge 25 procedures. (2) CCTV will be present in all public areas and will be monitored with recordings kept for 28 days and made available to Police on request. (3) All incidents that take place on the premises or immediately outside the premises will be recorded and made available for the Police on request. (4) A Refusals Log will be maintained at all times and made available on request of the Police or an authorised officer of the local authority. (5) Numbers of customers entering the premises will be limited due to the size and seating available, staff will

monitor numbers at all times throughout opening hours. (6) The premises will close at 11pm each evening to reduce the risk of any crime & disorder.

Staff are trained, due diligence and family run atmosphere will be strictly adhered to. No cash will be kept on the premises.

c) Public safety

(1) Staff Training will be carried out every six months and recorded for inspection by an authorised officer of the local authority in the Licensing Act 2003, Fire Safety, Health & Safety, Food Safety & Hygiene. (2) CCTV will be present in all public areas and will be monitored with recordings kept for 28 days. (3) A full Fire Risk Assessment will be produced and made available for inspection by Derbyshire Fire & Rescue or an authorised officer of the local authority. (4) All Fire fighting equipment will be provided and maintained by a professional registered supplier. (5) Sufficient lighting and handrails will be provided on the stairway to the cellar for safety of the public with signage for customers to take care. (6) Fire alarms / smoke detectors are fitted on both licensed floors of the property.

d) The prevention of public nuisance

(1) CCTV will present in all public areas and will be monitored to ensure that there is no anti-social behaviour on the premises or immediately outside the premises. (2) Staff will receive training in order to reduce the risk of nuisance by noise and waste. (3) The front of the premises will be cleaned immediately outside to ensure there is no waste including cigarette butts. (4) There will be no amplified music played on the premises. (5) Doors and windows will be kept shut at the front of the premises if any music is played. (6) When live music is played on the premises staff will periodically monitor the sound in the street to reduce the risk of noise pollution to any neighbouring premises. (7) The number of persons permitted on the premises will be limited by staff due to the size and seating available which will reduce the risk of anti-social behaviour. (8) Signs will be displayed at the exit door for all patrons to leave quietly and respect neighbours of the premises. (9) When customers are stood outside the premises whilst smoking staff will monitor these customers and remind them when necessary to respect neighbours.

e) The protection of children from harm

(1) No children will be permitted on the premises after 8pm. (2) Any children on the premises prior to 8pm will be accompanied by an adult and monitored at all times. (3) An Age Verification Policy will be in place and made available to the Police or an authorised officer of the local authority on demand. (4) A strict Challenge 25 Policy will be put in place with all refusals recorded in a Refusal Register which will be made available to Police or an authorised officer of the local authority on demand.

audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.

- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:

- any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
- o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
- o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
- o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their share code (provided to them upon accessing the service at https://www.gov.uk/prove-right-to-work) which, along with the applicant's date of birth, will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

An online check will not be possible in all circumstances because not all applicants will have an immigration status that can be shared digitally. The Home Office online right to work checking service sets out what information and/or documentation applicants will need in order to access the service. Applicants who are unable to obtain a share code from the service should submit copies of documents as set out above.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.
